

Technical Analysis: COIN now trading below the VWAPs from May and June lows and keeps failing at major resistance, a pattern that looks to want to play out lower out of a tight compressed range.



Fundamental Analysis: COIN now has a market cap of \$15.5B and continues to face major headwinds from regulatory concerns with crypto, competition in the trading platform space for crypto and the low volumes trading as interest in the alternative coins fades. COIN posted monster numbers in 2020/2021 but revenues seen down 56% Y/Y in 2022 and forecasts seeing 23.5% growth in 2023 seem overly optimistic while EPS seen sharply negative and the company will lose money in 2022. COIN is losing market share overall while the entire crypto space is facing a major loss of credibility with all the scams and hacks taking place and COIN looks like it will face a lot more issues going forward. Analysts have an average target of \$96.50 with short interest at 17% of the float. DA Davidson out positive eon 9/30 on the market-leading staking opportunity and upside to interest income with rising rates an the JV with Circle. Wells Fargo started Underweight on 9/29 citing weaker fees, rising competition and regulatory headwinds.
