Market Review: Stocks were weak overnight and losses accelerated in the premarket, particularly in Tech as 10-year yields jumped above 1.75% for the first time in over a year. Philly Fed came in very strong for March as the economy continues to heat up though Jobless Claims also came in well above expectations. It was another growth to value rotation as Banks, Metals, Industrials and Housing were strong while weakness seen across Tech groups like Software, Internet and Semiconductors. The S&P found support early bouncing right on the rising 8-day moving average. Breadth weakened in the early afternoon and saw selling accelerate just before 1pm. Markets continued lower in the afternoon as the Europe COVID outbreak is worsening as another wave from the variants strikes. Oil was down 7% as global growth now comes into question. It was a choppy post-FOMC session and no real major takeaways, market remains in a healthy uptrend and continues to see rotations focused on yields.

United Air Calls Hot on Upside to Business/International Travel

Ticker/Price: UAL (\$62.40)

Analysis:

United Air (UAL) traded over 85,000 calls on 3/17 which is 2X daily average but most notable were big buys of September \$65 calls that started at \$8.30 and caught the first 2500X bought and ended the day trading more than 13,000X and up to \$9.50, significant position size. UAL also has 10,000 April 1st (W) \$70 calls in OI from buyers 3/15, 8500 June \$57.50 calls, over 12,000 June \$50 calls and April \$60 calls, and some size in LEAPS, a ton of bullish flow since December. UAL shares are overbought near-term with a 61.8% retracement target at \$65.75 a potential stall point, but potential to work back to the pre-COVID range of \$75/\$95. The \$18.3B Airliner trades 20X Earnings, 7.2X FY22 EBITDA and 3X Book. Forecasts see UAL revenues rising 50% in 2021 and 2022 and EBITDA reaching \$5B in 2022 which would still be under the \$6.84B from 2019. UAL has invested in air-taxi start-up Archer that is a recent SPAC. UAL utilized the downturn to reduce \$2B in structural costs and is very optimistic for 2022/2023 and sees EBITDA margins in 2023 returning to at least 2019 levels and improving from there. UAL has the seven best Hubs and a strong rote network with the biggest business network of any U.S. airline, the largest coastal exposure in the coastal hubs, the largest international network. Analysts have an average target of \$52.50 and short interest is 5.5% of the float. Goldman was out on 3-15 raising expectations on the pace of air travel demand recovering, and now expects 2022 and 2023 demand to be 5% lower and 9% higher than 2019, respectively, vs. prior forecasts of 12% lower and 1% higher. UAL was featured as a name to buy trading at a large discount to historical multiples, as the most attractive option to gain exposure to the recovery in business/international and has a \$74 target. Deutsche Bank upgraded shares to Buy on 2-22 with a \$60 target. Hedge Fund ownership surged more than 20% in the latest quarterly filings, Altimeter a notable top holder and Jericho with a new position.

Freeport Calls Position for Further Copper Upside

Ticker/Price: FCX (\$35.84)

Analysis:

Freeport McMorran (FCX) shares have more than doubled since out write-up on 10-6 from size bullish options positioning and the activity has continued to be robust, a name with a ton of call open interest remaining in April and May but want to focus on some recent action in August expiration with the \$37 calls bought 5000X on 3/16 after the \$39 calls opened 2500X on 3/15. FCX also on 3/8 with January \$32/\$50 call spreads opening 7500X and has seen May \$40 calls climb over 21,000X in OI. FCX shares are consolidating the last few weeks above its rising 8-week moving average and put in a strong reversal candle on 3/17 above trend support, the next leg higher likely targets a move to \$45. FCX's portfolio of assets includes the Grasberg minerals district in Indonesia, one of the world's largest copper and gold deposits; and significant mining operations in North America and South America, including the large-scale Morenci minerals district in Arizona and the Cerro Verde operation in Peru. FCX's Grasberg mine is the largest gold mine in the world, and management noted recently it could fund the entire mine just with gold sales at recent gold prices, despite it also being one of the world's largest copper mines. In general, demand for copper reflects the rate of underlying world economic growth, particularly in industrial production and construction. According to Wood Mackenzie, a widely followed independent metals market consultant, copper's end-use markets (and their estimated shares of total consumption) are construction (28 percent), electrical applications (28 percent), consumer products (21 percent), transportation (12 percent) and industrial machinery (11 percent). China is the largest purchaser of Copper and seeing a strong economic recovery while electronics demand as well as EV expected to boost copper demand, and supply continues to be tight. Additional sources of copper demand in the future includes (i) high efficiency motors, which consume up to 75 percent more copper than a standard motor; (ii) electric vehicles, which consume up to four times the amount of copper in terms of weight compared to vehicles of similar size with an internal combustion engine, and require copper-intensive charging station infrastructure to refuel; and (iii) renewable energy such as wind and solar, which consume four to five times the amount of copper compared to traditional fossil fuel generated power. Additional capacity takes years to ramp up, given required permitting, mine plan development, etc. Mines globally have largely recovered from COVID-related disruptions, yet further capacity additions are limited. The largest global producer, Codelco, has said it must spend \$40B this decade to keep volumes flat. FCX's market cap now stands at \$51B and trades 13X Earnings, 5X Book, 17.5X FCF and 7.6X FY21 EBITDA with a yield of 0.86%. Bloomberg reported that FCX may be an acquisition target in September though management did not appear willing to sell. Analysts have an average target of \$35 and short interest low at 1.6% of the float. Citi raised to Buy on 2/17 raising copper price forecasts and JPM called copper a long-term secular demand story.

Union Pacific Bulls Target Strength into 2H as Industrial Recovery Accelerates

Ticker/Price: UNP (\$216.50)

Analysis:

Union Pacific (UNP) with 1200 August \$220 calls bought for \$12.45 to \$12.75 and follows the April \$220/\$240 call spread bought last week over 2,000X. Shares are starting to work out of a small flag today after pulling back to the recent breakout range and just below new highs at \$220. A very coiled name, UNP is clearing a big volume node and a run higher has a measured move up to \$240-\$250. The \$143B rail leader trades 20X earnings, 7.3X sales, and 47X FCF with a 1.8% yield and low-double digit growth. UNP was at the JP Morgan conference this week noting that they continue to see tailwinds into the 2H of the year from improvements in GDP and industrial production. The company expects to continue winning share over trucking in the near-term as fuel costs weigh and freight car velocity is rebounding with a pickup in premium being driven by ecommerce volumes. UNP should see a 2H boost as the auto bottlenecks from the chip shortage get resolved. Hedge fund ownership fell 2.5% in Q4. Analysts have an average target for shares of \$205 with a Street High \$250. Raymond James positive in January noting that they continue to expect UNP's implementation of Precision Scheduled Railroading to yield a more profitable and reliable network than some may think. Bernstein upgrading to Buy in January noting that UNP should continue to work as higher highway costs and modal advantages make the idea of a more growth focused rail narrative more of a reality.

Sumo Bull Spreads Position for Recovery into 2021

Ticker/Price: SUMO (\$21)

Analysis:

Sumo Logic (SUMO) elevated bullish activity all week with 2,000 August \$25/\$17.50 bull risk reversals bought today, look to be adding to the 2,000 opened vesterday, and on Tuesday the April \$25/\$30 call spread 2000X for \$0.86 and selling the April \$20 puts 1500X for \$1.34. On 2/24, SUMO saw spreads buying 1000 November \$30 calls for \$11.50 and selling the November \$35 puts to open at no cost. Shares are back around the post-IPO lows from 2020 after trading as high as \$40 in February. SUMO debuted at \$26.50 and strong run on volume after breaking out in November. The \$2.18B software company trades 5.3X cash and 12.3X EV/sales with 16.5% growth in FY22 and 20%+ in FY23. SUMO has seen strong demand over the last year for their monitoring platform Continuous Intelligence as more businesses transform into digital-first platforms and continue to see Public Cloud growth as a major opportunity. SUMO operates in a competitive space with Dynatrace (DT), Datadog (DDOG), and others embedded already but they think their TAM can grow up to as much as \$55B as they expand product reach into End-User Query, Reporting, and Analysis - the latter the largest space at \$15B. They also see competitive advantage as the only vendor in Log Analytics + SIEM to have built a multi-tenant cloud platform. Analysts have an average target for shares of \$32 with a Street High \$44. BTIG with a \$35 PT but positive on 3/11 noting that guidance will prove conservative, and they like the long-term exposure to large established growth markets, greenfield opportunities as more workloads migrate into cloud environments, and tangential opportunities in APM and infrastructure monitoring. Short interest is 2.5%. Hedge fund ownership rose 58% in 04.
