

## Solar Next Growth Group to Run, Sunrun Attractive Based on Flows, Inverted Skew



**Technical Analysis:** RUN quietly broke out of June OpEx value range Monday and into a volume pocket, also clearing a long downtrend from the early 2021 highs and RSI back above the 50 level. Shares have plenty of room for a retracement move, 38.2% at \$61.70, while VWAP off those highs is near \$57.75.



Fundamental Analysis: RUN has a \$9.43B market cap and runs a solar-as-a-service model, which provides clean energy to households with little to no upfront cost and at a saving compared to traditional electricity. The company designs, installs, finances, insures, monitors and maintains the systems, while families receive predictable pricing for 20 years or more. The company also offers a home solar battery service, Sunrun Brightbox, that manages household solar energy, storage and utility power. RUN has also been highlighting its grid services at recent investor presentations. RUN's value proposition to customers continues to improve and with that it will see accelerated penetration. As the market leader in residential solar yet having < 1% of the share of US residential electricity generation, the opportunity is enormous over the next ten years. RUN is trading at 9.7X EV/Sales with revenues seen rising 57.7% in 2021 and 15% in 2022. US residential remains early-stage at less than 150,000 households for energy storage and volumes appear to be accelerating with 1Q21 deployments up over 150% owing to improved affordability, higher solar penetration and heightened customer concerns over grid stability in light of recent events in CA and TX. Solar could get a boost from the eventual Biden infrastructure plan and potential storage-only ITC. Recent proposals from the Biden administration within the American Jobs Plan have detailed a 10-year extension for the solar ITC, alongside other pro-clean energy initiatives included with the bill. RUN has a leading position in key states like California and Hawaii. Analysts have an average target of \$80 and short interest is elevated at 15.7% of the float. Guggenheim positive on 6/2 of its growing scale and RUN is leveraging its advantages. Truist lowered its target to \$81 on 5/7 but noted all relevant metrics outperformed in Q1 with strong execution. Tiger Global, Coatue and Viking Global all notable top holders.

**Options Activity:** RUN has large bull risk reversals in August and November expirations and upside January call spreads. Its 30-day IV Skew at -4.3 is sharply inverted.
