WEEKLY RADAR REPORT 1-10-2021





Technical Market View

The **S&P 500** continued its strong recent run this week breaking out of a narrow five-week range and closing strong despite some political headlines and a weak jobs number on Friday. We dipped down to test VWAP from the Pfizer vaccine announcement on Monday and buyers defending well with a quick bounce back. The current range targets a move out to 3925.75 and aligns with our target from the September/October out to 3,975. After four straight sessions higher, a pullback may be warranted early in the week and the 8-EMA at 3756.50 is the first area of interest while 3,711 and the 21-day would be the next. Below there would be bring some pressure down to 3600. MACD crossed back over bullish this past week while RSI is in a strong trend too, plenty of momentum for a sustained run higher.



Market Sentiment/Breadth

The latest AAII sentiment survey for the week ending 1/6 showed a slight increase in bulls to 54%, up from 46.1%, while bearish responses stayed the same around 26.5%. This is the highest bullish sentiment in four weeks and just below the 1-year high at 55.8%. NAAIM Exposure rose to 94.51, bouncing back from the recent dip but not yet near an extreme high. Lipper Fund flows had \$5.4B in outflows from equities, the largest exodus in three weeks. As of Friday's close there were 1386 new highs just 45 new lows, strong breadth. Over 86% of stocks were above their 50-day MA and 87.8% above their 200-day, continued strength. NYSE Summation is 937.43 and starting to curl higher, potential for an 8-EMA bull cross this week. Cumulative AD hit new highs this week. NYMO was 5.10 and remains in a neutral range. CBOE Equity P/C ratio 50-MA is 0.45 and remains overly complacent. CNN Fear and Greed is 72 and jumping this week.

Weekly Open Interest Radar

Costco (COST) shares setting up well on the weekly with a bull flag above the rising 21-week MA and potential for an strong move to new highs. Shares have been in a strong longer-term trend and MACD and RSI both in healthy areas after a bit of a reset. On the daily, a reversal day just above the most recent low with a moving average cluster around \$372.50 in focus. COST has seen a lot of bull flow lately including 3,000 March \$380 calls bought around \$13 while the \$385 calls also seeing activity. The June \$400 calls with 1,450 in open interest from buyers as well.

The \$162.85B company is a best-of-breed name and trades 33.7X earnings, 0.94X sales, and 11.3X cash with a small yield and high-single digit growth. COST has long been one of the best names in retail with their club model, strong renewal rates, and massive cardholder base. Analysts have an average target for shares of \$386.50 and a Street High \$435 from Jefferies. BMO sees the company prevailing despite increased competition as they offer an unmatched price/value equation. Baird positive on 1/6 after their December sales were a bit soft but highlighting that the main areas of weakness were food and sundries which was likely due to smaller Holiday gatherings and should rebound in January. Hedge fund ownership rose marginally last quarter with notable buys from Winslow Capital.

Insider Trade of the Week

Cannae (CNNE) starting to work out of a big monthly range and name that saw notable insider buying in December with the CEO adding 15,000 shares at \$42.33, a more than \$630k investment. CNNE has traded higher by 16.5% in the last year and just starting to get back above the February 2020 highs. The longer-term move targets \$55-\$60. The \$4.16B company trades 6X sales and 10.25X cash. CNNE is an investment firm with a variety of names under its banner including Dun & Bradstreet, Ceridian, and Core Logic. The former returned to the public markets in 2020 and working through more than \$250M in cost-savings while executing on growth initiatives despite the headwinds from COVID. CNNE has been an active name and likely looks at doing further deals in 2021. They have a strong balance sheet, over \$1B in cash, and virtually no debt. In December, CNNE announced a \$350M investment the Bill Foley SPAC (BFT) that is acquiring PaySafe. Institutional ownership fell 18% in Q3 although Eminence Capital buying 1.1M shares. Analysts have an average target for shares of \$46. OpCo started coverage on 11/19 with a \$49 PT. The firm thinks CNNE trades at a discount to its main three holdings which gives investors "a free option on Cannae's forward purchase agreements and founder shares in three SPACs including the announced Paysafe."

Earnings Preview


KB Home (KBH) reporting earnings on Tuesday after the close with the Street looking for \$0.93 on \$1.145B in sales. Shares have closed lower each of the last four with an average closing move of 6.73% and a max move of 11.85%. The current implied move is 5.58%. The \$3.07B company trades 7.45X earnings, 0.67X sales, and 11.87X FCF with a 1.8% yield and double-digit growth. Short interest is 4.5%. KBH is coming off a strong quarter with better ASP, a lower cancellation rate and continued strong demand from first-time buyers. They also re-started land purchases for development which will give them a better outlook into 2021/2022 as they expand their community footprint into the future. KBH is likely to talk about the sustained demand environment as rates remain low and the swell of buyers active for housing alternatives outside of the city due to COVID. Hedge fund ownership fell 11.9% in Q3, Greenhaven a big seller of 1.9M shares while Basswood Capital started a small position. Analysts have an average target for shares of \$40 and a Street High \$49. JP Morgan upgrading to Neutral in November citing valuation while the housing market recovery "has legs and builders' metrics also have room to run. Seaport upgrading to Buy as the company has substantially deleveraged and in a much better position than they were a few years ago. They see substantial upside if the housing market remains firm. KBH has seen mostly bullish flow with buyers recently in the Jan. 2022 \$32 calls and put sellers in the Jan. 2023 \$20 puts and July \$32 puts.




Top 40 Micro-Cap Profile of the Week

TCR2 Therapeutic (TCRR) was a successful small cap Biotech in 2020 with shares gaining around 100% and will be presenting at the JP Morgan Healthcare Conference this week on 1-14-.

TCRR is a clinical-stage immunotherapy company developing the next generation of novel T cell therapies for patients suffering from cancer by overcoming the limitations of chimeric antigen receptor T (CAR-T) cell therapies and engineered T cell therapies that use the full T cell receptor (TCR-T cells). Its proprietary TCR Fusion Construct T cells (TRuC-T cells) specifically recognize and kill cancer cells by harnessing the entire T cell receptor TCR signaling complex. TRuC-T cells tumor cell recognition does not require human leukocyte antigen (HLA), which provides two important benefits. First, in contrast to current engineered TCR-T cells, its technology is designed so that it can be applied to all patients that express the cancer surface antigen irrespective of HLA subtype, which can address a significantly larger patient population. Second, HLA is downregulated or lost in many tumors, which can prevent their recognition by T cells and lead to diminished response rates and higher relapse rates.



Its lead candidate is TC-210 to treat patients with non-small cell lung cancer (NSCLC), ovarian cancer, malignant pleural/peritoneal mesothelioma and cholangiocarcinoma. It estimates a target population of 80,000 patients across those indications. TC-110 is targeting hematological malignancies and is for indications for which CAR-T cells have either not been approved (indolent NHL), have proven too toxic (aALL) or have benefitted only a minority of patients (aggressive NHL). TCRR's pipeline also includes cell therapies such as the hostile and immunosuppressive tumor microenvironment.



TCRR is not revenue generating as it is clinical stage but has \$247M in cash with runway into 2023 and its platform truly looks to have massive potential across multiple cancer indications to improve current therapies in solid tumors. TCRR is early stage and will have a lot of data catalysts in 2021 but thus far it looks to have massive potential.
