

WEEKLY RADAR REPORT 12-12-21



Technical Market View

The **S&P 500 (SPX)** bounced back last week after pulling back to key support and now sitting just under new all-time highs. We consolidated for most of the week in a narrow range above the rising 8- and 21-EMA as short-term momentum shifts back to the bulls and now looking for the confirmatory push back to new highs. Overall, the path of least resistance now is to the upside and the top of monthly value is at 4708.50 and a breakout move on early watch for the week. Momentum starting to pick up as well with both MACD and RSI starting to turn higher after resetting during the latest pullback. A move above 4740.50 has room to run to 4757.25 and then 4790.25. The 8-EMA is supportive at 4652 and key line in the sand for short-term momentum. A breakdown can re-test 4628.50, 4610.50 and then 4591.



Market Sentiment/Breadth

AAII sentiment for the week ending 12/8 showed bullish responses up to 29.7% vs 26.7% prior while bearish responses fell sharply to 30.5% from 42.4%. Neutral sentiment jumped to 39.8% from 31%, the highest level is almost two years. NAAIM Exposure fell again to 69.46 and its lowest mark since mid-October. A move under 60 is considered an extreme and certainly nearing that level of sentiment. Lipper Fund flows for the week ending 12/8 showed \$1.5B in outflows from equities. As of Friday's close we had 134 new highs vs 186 new lows, balanced breadth. On the NYSE, New Highs minus New Lows was -17, far better than the -180 print the prior week. The percentage of stocks above their 50-day MA was 39.6% and remains below average while those above their 200-day was 50.54 and remains weak. NYMO jumped off of extreme oversold levels for the week back up to +16 and closed at -10.29, a neutral reading. Both NYSI and NASI flattened out a bit but remains below their respective 8-EMA. CBOE Equity P/C 50-day MA remains subdued at 0.471. CNN Fear and Greed was 38, up from 20 last week, but remains 'fear.'

Per the Trader's Almanac,

- Monday Before December Triple Witching, S&P is up 13 of the last 20 years.
- December Triple Witching Expiration Friday, S&P is up 26 of the last 38 years.
- December 4th quarter options expiration week is the most bullish triple witching week, S&P up 27 of 38 years. Average gain +0.5%.
- Small cap stocks start to outperform large caps near the middle of December and continue into March.

More recently in the last 21 years of stats below, Dec OPEX week has a bullish bias overall with strength midweek that tends to fade the actual Friday of OPEX being up just 8 of the last 21 years. The strongest day of the week has historically been Wednesday with the S&P up 62% of the time since 2000, or 13 of the last 21 years. Looking forward to the following week, the week of Christmas has a bullish bias with the last trading day before Christmas up about 71% of the time since 2000. This is traditionally the start of the Santa rally that sees lower volatility drift into year end.

BBWI has seen a lot of bullish flow including buyers in the February \$75 calls over 5000X and May \$85 calls over 6500X.

Credit Spread of the Week

Semiconductor Leader Building Long Base in Bull Trend

Taiwan Semiconductor (TSM) - TSM has been consolidating 2020 gains for much of the last 6 months of this year building a long base near the stocks year to date VPOC just under 120. The stock is a lower volatility Semi leader compared to its peers like AMD and NVDA but looks to have found a floor in this 115-120 zone after the recent pullback from its November highs near 127. After breaking that downtrend line it is now back testing that former breakout and likely to hold 120 as support going into January. RSI has reset back to 50 on the daily and the weekly RSI staying above 50 as well indicating the bull trend intact. TSM has a long weekly and daily squeeze forming on multiple timeframes which points to a large move coming soon. The stock has held its 200 day EMA as support below numerous times the last several months and that continues to point higher. An optimal spot to enter a bull put spread expecting the 120 level to hold into year end and January expiration. Seasonality does turn quite bullish for TSM in Jan-Feb with the stock being up 7 of the last 10 years in January for about an average gain of +3%. Options flows are mostly bullish in TSM and on 12/10 saw an opening put sale in September \$110 puts sold at \$8.45 for \$1.1M. Also back on 11/19, a large buyer of March \$100 deep ITM calls were bought at \$25.35 for \$6.7M in premium and are still in open interest.

Trade to consider: Sell TSM January 120/115 put spread for 2.25 credit or better



Insider Trade of the Week

Alight (ALIT) has seen a number of insider buys recently including a \$320K investment from a director on 12/10 at \$10.79. This follows buyers in August around \$10 including the CEO and a \$1M buy from director Bill Foley at \$9.99. Shares have pulled back to a volume node from August at \$10.40 and low-end of a channel that has room up to \$11.50. A breakout move targets \$13.75. The \$5.83B company trades 12.1X earnings, 2.12X sales, and 12.67X cash. ALIT is a leading benefits administration and cloud-based HR services provider with 30M employees covered, 96% average revenue retention, and 81% recurring revenue. The firm has developed Business Process as a Service (BPaaS) and the model brings together SaaS capabilities and an automated service delivery model with data & AI to deliver superior outcomes for clients. Their TAM is growing with 3.5B employees worldwide and over \$3.5T in US healthcare spending. They see big thematic trends driving long-term growth including healthcare affordability, workforce mobility, and greater regulatory compliance. CSFB starting coverage at Outperform in August. The firm thinks Alight offers investors a unique opportunity at an attractive entry level for an accelerating organic growth story-fueled by higher-growth analytics-leveraging datasets. The company is positioned for multiple expansion as revenue remixes to analytics verses health and wealth and payroll processing. DA Davidson positive in July and positive on the company's position as the leading provider of integrated human capital solutions for mid/large corporations. They also like Alight's high levels of recurring revenue, its blue-chip customer base, and solid margins. Hedge fund ownership jumped 150% last quarter. Third Point a buyer of 17M shares, Appaloosa adding 8M shares, and Cadian Capital with 3.5M shares.

Earnings Preview

Lennar (LEN) reporting earnings on 12/15 after the close with the Street looking for \$4.16 on \$8.5B in sales, up 20% Y/Y. Next quarter is guided to \$2.86 and \$6.52B while the FY is \$14.28 and \$26.63B. Shares have a strong history closing higher in six of the last eight with an average closing move of 3% and a max move of 13.8%. The current implied move is 3%, a big below the average implied move of 4.85%. The \$35.63B company trades 8.05X earnings, 1.4X sales, and 12.8X cash with a small yield. LEN has been executing well despite a difficult environment where supply and labor pressures are expected to continue into Q4 and early 2022. They were cautious on announcing 2022 deliveries guidance in

September due to both of these overhangs but they remain in strong position to grow in the low-double digit range with demand for new orders strong. Analysts have an average target for shares of \$120 with a Street High \$166. Goldman upgrading to Buy on 12/1 citing the company's roll out of larger, volume focused communities which should support double digit revenue growth and EBIT margin expansion. In addition, the announced spinoff of non-core assets could result in a 500 basis point improvement in the homebuilding return on equity from Q3's 22%, moving Lennar closer to, if not ahead of, best in class peers. Short interest is 2.55%. Hedge fund ownership fell 1.6%. Castle Hook Partners a buyer of stock while Sanders Capital a top holder with 10.4M shares. On the chart, LEN broke out of a weekly bull flag recently above \$110 and measured move to \$130 as a continuation of the bigger bull trend. Options flow has been bullish with recent buyers in the December 23rd (W) \$120 calls, May \$115 calls, and December \$115 calls over 8000X for \$1.3M. The February \$90 puts were sold to open 4000X on 11/29 for \$730K.

Digi International (DGII) shares are +29% YTD and last week saw unusual buys of June 2022 \$25 calls as shares trade back near new highs.

DGII is a global provider of business and mission critical IoT connectivity products, services and solutions. The IoT Products & Services segment offers products and services that help OEM, enterprise and government customers create and deploy, secure IoT connectivity solutions. The IoT Solutions segment primarily consists of its SmartSense business which offers wireless temperature and other condition-based monitoring services as well as employee task management services with a focus on food service, healthcare and supply chain industries. DGII acquired Ventus in November, a leader in Managed Network-as-a-Service (MNaaS) solutions.

The IoT industry is in the midst of a multi-year expansion as many industries are undergoing a digital transformation within their business that drives demand for IoT capabilities across a broad spectrum of services. Among others, IoT use cases include automating workflows, condition-based monitoring and asset tracking. The market opportunity is estimated at \$38B in 2023 growing at a 15% CAGR.

DGII has a market cap of \$845M and trades 48X Earnings, 2X EV/Sales and 15.3X FCF with a strong cash-rich balance sheet it has utilized to fund multiple acquisitions in 2021. Consensus forecasts expect 19% revenue growth in 2022, best since 2018 along with 120% EBITDA growth. Digi has a unique combination of revenue growth, profitability growth, and cash generation, combined with accelerating recurring revenues. SmartSense, its IoT Solutions business segment, added over 2,000 subscribers in the quarter, driven by health care and retail verticals and now with over 81,000 subscribers powering over \$24 million in ARR, which grew 38% from last year. The multibillion-dollar opportunity has significant greenfield opportunity, and SmartSense is well positioned to capture increased market share.

DGII is a low multiple grower in an IoT theme in the early innings and its recent transformational acquisition is accretive and adds to its attractive financial profile, a name that continues to thrive under the radar of most investors.
