






Technical Analysis: VALE shares are working out of a pullback trend after defending key support and the weekly cloud, back above all key moving averages on the weekly timeframe and MACD nearing a bullish crossover that can accelerate a trend move higher.



Fundamental Analysis: The \$72B industrial metals company with a focus on Iron Ore trades 8.45X Earnings, 2.13X Sales, 11.8X FCF and 6X EBITDA with a 3.5% dividend yield and substantial cash. VALE has accumulated a sizable amount of cash flow and could look to special dividends, buybacks, or acquisitions, recently a \$500M deal for New Steel and could fund a \$1B Brazilian copper project. VALE has moved off 2018 highs with concerns on the slowing China market for Steel, but shares look set to re-rate on the capital allocation potential. On 12-11 Macquarie upgraded shares to Outperform. Hedge Fund ownership jumped 23.9% in last quarter's filings, Impala Asset Mgmt. taking a large new position. China has started to take easing steps that could boost demand for Steel and Iron Ore. Goldman and Morgan Stanley have been out negative on Iron Ore prices for 2019 seeing weaker demand and rising supply. However, Iron Ore has been resilient and prices are climbing rapidly nearing recent highs.
